

TERMS AND CONDITIONS

Lifetime & One-Year Membership Draw – Athlone Golf Club

1. Promoter

1.1 The promoter of this draw is **Athlone Golf Club** (“the Club”).

1.2 The draw is conducted under a valid lottery licence issued in accordance with the Gaming and Lotteries Acts 1956–2019 in the Republic of Ireland.

2. Eligibility

2.1 The draw is open to persons aged 18 years or over at the time of entry.

2.2 Club members, including Committee members and members involved in selling tickets, are eligible to enter.

2.3 To ensure fairness and transparency:

- Any member involved in selling tickets shall not be responsible for the recording, verification, or custody of entries;
- Any Committee member who enters shall not be involved in supervising or conducting the draw;
- All entries will be centrally recorded and secured by designated persons who are not participants in the draw.

2.4 By purchasing a ticket, entrants agree to be bound by these Terms and Conditions.

3. Entry Period

3.1 The draw opens on 20 April 2026 and closes at 7.30 pm on 27 November 2026.

3.2 Tickets purchased after the closing time will not be included.

4. How to Enter

4.1 Tickets may be purchased:

- In person at the Club premises;
- From designated Club members who have been authorised by the Club to sell tickets (“Authorised Sellers”); and

- Online via the official Club link, including via the official QR code issued by the Club.

4.2 Authorised Sellers act solely as ticket sales agents on behalf of the Club. All ticket stubs, purchaser details, and funds collected must be returned to and recorded by the Club prior to the draw in accordance with licence requirements.

4.3 Ticket pricing is as follows:

- 1 Ticket for €20
- 3 Tickets for €50
- 7 Tickets for €100
- 15 Tickets for €200

4.4 Each individual ticket constitutes one separate entry into the draw.

4.5 Online entries are valid only upon successful payment confirmation.

4.6 The Club accepts no responsibility for technical failures affecting online transactions.

5. Ticket Control and Recording

5.1 All physical tickets issued to Authorised Sellers shall be sequentially numbered and recorded by the Club prior to distribution.

5.2 Authorised Sellers must:

- Record the name and contact details of each purchaser;
- Issue the appropriate ticket stub or confirmation;
- Return all sold ticket proceeds, unsold tickets, and corresponding records to the Club by the specified deadline.

5.3 No ticket shall be included in the draw unless:

- Full payment has been received; and
- The purchaser's details have been recorded in the official entry register maintained by the Club.

5.4 The Club shall maintain a centralised register of all valid entries (both in-person and online) prior to the draw taking place.

5.5 Once entries are finalised and recorded, no further amendments may be made except to correct manifest administrative errors.

6. The Prizes

6.1 The prizes consist of:

- One (1) Lifetime Playing Membership; and
- Five (5) One-Year Playing Memberships
- Three additional Draws will take place at time to be determined

6.2 The Lifetime Membership and One-Year Memberships cover the standard annual playing subscription fee only.

6.3 The One-Year Memberships are valid for one full membership year commencing on **[start date or next membership cycle]** and will expire automatically at the end of that membership year.

6.4 The prizes are non-cash, non-refundable and non-exchangeable.

7. Exclusions (Apply to All Prizes)

The Lifetime Membership and One-Year Memberships do **not** include and the holder remains responsible for:

- Golf insurance
 - Golf Ireland / affiliation fees
 - Development levies or capital charges
 - Competition entry fees
 - Cart/buggy hire
 - Locker rental
 - Equipment hire
 - Food and beverage purchases
 - Any ancillary or optional charges
 - Any future levies introduced by the Club that are not the standard annual subscription fee

8. Transfer of Prizes

8.1 Each prize is transferable **once only**, strictly at the time of winning.

8.2 The winner must nominate any transferee in writing within 30 days of notification.

8.3 After this period, the prize becomes permanently non-transferable.

8.4 The transferee must meet eligibility requirements and agree to these Terms and Conditions.

9. Duration and Termination

Lifetime Membership

9.1 The Lifetime Membership is valid for the natural lifetime of the individual holder.

9.2 It will automatically terminate upon:

- The death of the holder;
- The holder permanently ceasing to play golf (see Section 15);
- Written resignation from the Club;
- Expulsion or suspension under the Club's Constitution and Rules.

9.3 "Lifetime" refers solely to the lifetime of the individual holder and does not create an inheritable right or estate asset.

One-Year Memberships

9.4 Each One-Year Membership expires automatically at the end of the applicable membership year and carries no renewal entitlement.

10. Conduct of the Draw

10.1 The draw will take place on **27 November 2026** at **the Athlone Golf Club**.

10.2 Winners will be selected at random from all valid entries.

10.3 The draw will be conducted by an independent person who:

- Is not a participant in the draw;
- Is not involved in ticket sales; and
- Has no conflict of interest in the outcome.

10.4 The independent person's decision is final.

10.5 Winners will be notified within 7 days. If a winner cannot be contacted within 14 days, the Club reserves the right to redraw that prize.

11. One Prize Per Person

11.1 Each individual entrant is eligible to win **only one prize** in this draw.

11.2 If an individual's entry is drawn for more than one prize, only the first prize drawn will be awarded, and any subsequent prize(s) shall be redrawn.

11.3 This applies to both the Lifetime Membership and the One-Year Memberships.

12. Publicity

12.1 By accepting a prize, winners agree to reasonable publicity unless they request otherwise in writing.

13. Data Protection

13.1 Personal data will be processed solely for administering the draw and in accordance with applicable data protection legislation.

14. Definition – Permanently Ceasing to Play Golf

14.1 A member shall be deemed to have permanently ceased playing golf if, in the opinion of the Club:

- The member has not played at least 2 rounds of golf or participated in Club competitions over a consecutive 24 month period; **or**
- The member submits a written declaration to the Club confirming they no longer intend to play golf; **or**
- The Club reasonably determines that the member has permanently stopped engaging in golf-related activity at the Club.

14.2 The Club reserves the right to request reasonable evidence or confirmation from the member to support the determination.

14.3 Once the Club determines a member has permanently ceased to play golf, the Lifetime Membership shall automatically terminate.

15. General

15.1 All prizes are subject at all times to the Club's Constitution, Rules and Bye-Laws, as amended from time to time.

15.2 The Club's decision in all matters relating to the draw is final.

15.3 These Terms and Conditions are governed by the laws of Ireland and subject to the exclusive jurisdiction of the Irish courts.

This now fully covers:

- Ticket sales in-person, via authorised members, and online/QR
- Independent draw oversight
- Pricing tiers
- Multiple prize types
- Exclusions and transfer rules
- Lifetime termination conditions
- One prize per person
- Seller controls
- Definition of “permanently ceasing to play golf”

How to Enter

- Tickets available **in person at the Club**, from **authorised Club members**, or **online via QR code**.
- Ticket pricing:
 - 1 Ticket – €20
 - 3 Tickets – €50
 - 7 Tickets – €100
 - 15 Tickets – €200
- Each ticket counts as **one entry**.

Who Can Enter

- Open to anyone **18+**, including Club members and Committee members.
- Sellers of tickets may enter but **cannot handle or conduct the draw**.

Prizes

- 1 × **Lifetime Playing Membership**
- 5 × **One-Year Playing Memberships**
- Prizes cover the **standard annual subscription only**. Other fees (insurance, development levies, competition fees, etc.) are **not included**.

Transfer

- Prizes are **transferable once** at the time of winning.

Draw Details

- Draw conducted by an **independent person** on 27 November 2026
- Each entrant can **win only one prize**.
- Winners will be notified within 7 days.

Lifetime Membership Notes

- The Lifetime Membership ends if the winner dies or **permanently ceases to play golf**.
- One-Year Memberships expire automatically after the membership year.

Important

- Winners agree to reasonable publicity unless they opt out.
- All entries are recorded and verified to ensure fairness.
- The draw is licensed under the **Gaming and Lotteries Acts 1956–2019 (Republic of Ireland)**.
